# **Conference Grounds**

Because of its location near the central California coast. Alliance Redwoods Conference Grounds was hit hard by both the COVID-19 pandemic and the historic wildfires in the area. Normally, Alliance Redwoods offers outdoor education for public schools, camps and conferences, and zipline tours. In April of 2020, the camp lost all of its contracts for group events. Suddenly its only offering—and its only source of income—was its zipline tours, which continued to be a popular choice for people looking for socially distant adventures.

Jim Blake, executive director, remembered, "We were kind of in a desperate situation last April." In response, Orchard Alliance converted Alliance Redwoods' existing loan to an interest-only period, significantly reducing the required monthly payments. Longtime donors continued—and in some cases increased—their gifts to Alliance Redwoods, preventing the camp's financial situation from becoming more dire.

With 400 empty beds and no overnight guests on site, Alliance Redwoods opened its doors to serve local people experiencing homelessness. On July 15, Alliance Redwoods became an official non-congregate shelter (NCS), licensed by the county to temporarily provide food and shelter to individuals in need of housing. Since then, hundreds of people have stayed at Alliance Redwoods.

Ultimately, Alliance Redwoods expects to resume its traditional education, camp, and conference programs, but Jim said the camp wants to do more than survive this difficult season. It wants to thrive by legitimately serving the community. He said, "God has a way of positioning you to be part of the solution. He has been faithful to provide what we need."

The support and creative financing from Orchard Alliance are helping to keep Alliance Redwoods operating despite the challenges. Jim said, "We don't see Orchard Alliance as just a bank; we see Orchard as a partner in ministry. We're appreciative to all the folks there."

LOANS SPOTLIGHT

### **Risen King Church**

Risen King Church has grown from a congregation of less than 100 to more than 700 weekly attendees during Lead Pastor Mike Plunket's tenure. Located just 20 miles north of Manhattan, Risen King is a multi-cultural church that reflects the diversity of the surrounding community. Every major ethnic group in Rockland County is represented in both the membership and the leadership of the church.

This diversity has created unity in Christ and what Pastor Plunket calls "an atmosphere of fellowship and friendship." On Sunday mornings and throughout the week, groups that gather in Risen King's building tend to linger and visit. Years ago, the church converted its offices into flexible space that would encourage those face-to face interactions. Pastor Plunket said. "We've had to be as creative with space as possible."

Despite the changes to the building, and even with four Sunday services, Risen King still needed additional space. When the house next door to the church property went up for sale in 2020, the congregation guickly agreed to purchase it with funding from Orchard Alliance. "God has been very faithful to supply our financial needs through every season of ministry," Plunket said, "including the COVID-19 pandemic. A loan from Orchard Alliance was just one way He has provided for the needs of Risen King Church."

Today, the house next door is used for staff offices, storage, and more. Much like the main church building, it has become a place where people love to gather and find it difficult to leave. Plunket said, "It's really been an incredible blessing to us already. Our staff needs tools to do their jobs, and this is an essential tool."

#### **INVESTMENTS SPOTLIGHT**



When Ministry Advance Foundation (MAF) was founded in the 1980s, its goal was to help fellow Christians understand biblical stewardship principles related to the development of personal estate plans.

The foundation was based on the belief that God owns everything and that His people are stewards of what God has entrusted to them.

Originally formed by eight Christian organizations, MAF's assets steadily grew over the years to a healthy portfolio of trusts, endowments, charitable gift annuities, and other charitable instruments. In recent years, the participating organizations decreased from eight to two—WorldVenture and Missions Door. As participation declined, MAF's board decided to wind down the foundation's operations and look for another organization to take the reins.



### We Knew We Would Be In Great Hands

"When our prior president retired it created a good opportunity to evaluate transferring the foundation responsibilities to another like-minded organization. Orchard Alliance was at the top of our list," said John Benza, vice president of partner relationships for Missions Door and MAF Board member. "We knew Orchard was well established, professional, and financially sound, but we also went with them because of their ideological alignment and shared values. Orchard Alliance is a spiritually minded organization, not commercially minded, and that was very important to us. We knew our account holders would be in great hands."

At the beginning of 2020, MAF transferred fiduciary responsibility of its charitable instruments, totaling nearly \$3.5 million, to Orchard Alliance. MAF also chose Orchard Alliance to issue charitable gift annuities on its behalf. "Orchard Alliance did an excellent job throughout the entire transfer process, said John. "From due diligence to all the paperwork, everything went smoothly and was handled with the utmost professionalism."
